

Dear Neighbors,

Our many appeals to the city and the developer to consider the safety of our neighborhood before excavation begins on the Revello-Tramonto Development have been ignored. When the Tramonto Slide encroached on PCH and Caltrans made it clear they could not safely remove the toe of the slide until the city addressed the head scarp, the city's answer was that its funds are currently dedicated solely to homelessness. In other words, the city will make NO FUNDS available for mitigation of the Tramonto Landslide.

WE ARE NOT ALONE. THIS SITUATION IS HAPPENING IN OTHER PARTS OF THE PALISADES.

It is a known fact the city has been quietly making off-market sales to developers of the substandard Castellammare lots it inherited after the landslides of 1959 and 1993, allowing these builders to restore stability, lot by lot, in whatever fashion they deem prudent.

CMHO has been contacted by other Palisades neighborhoods, specifically Paseo Miramar where grading and clear-cutting without permits have been performed on a long-standing slide area, and residents near 425 Mt. Holyoke Avenue, where a 3-story home with pool and spa is proposed on slide lots overlooking Temescal Canyon Park. Not surprisingly, some of the same bad actors are involved. Residents from both areas want to join forces with CMHO to stop the city of LA from selling landslide properties to developers whose only focus is the return on their investment.

In 2019 Crest Real Estate was charged by the City of Beverly Hills for **illegal lobbying tactics** and **falsification of information** provided on official government projects. Sound familiar? (See Article here)

EVEN IF CMHO WINS AN EIR, IT WILL NOT BE AN INDEPENDENT EVALUATION.

Based on reports by professionals selected by CMHO for their expertise in the fields of geology, hydrology, structural engineering, fire, noise and transportation, an appeal was submitted to the city urging that an EIR (Environmental Impact Report) be performed on the project site prior to final approval of the development. There is a CEQA hearing (date TBD), where a decision will be made either for or against an EIR. If we succeed and the EIR is performed, we discovered that the developer may choose who they hire from a city-approved list of professionals. That's the same city that sold the developers the substandard lots. So, the evaluation is NOT independent and hardly impartial. But it may give us the time we need to ramp up our opposition.

WE NEED VOLUNTEERS TO JOIN OUR EFFORT TO SAVE US FROM BECOMING VICTIMS.

The CMHO Board needs volunteer help from professionals skilled in communications and fundraising to win this battle against the city. If you or someone you know has the skills and time to help, here is what we need, starting now:
